Augusta Planning and Development Department Announces the 2035 Comprehensive Plan Update

The Augusta Planning and Development Department, on behalf of the Augusta Planning Commission, initiated the 2035 Comprehensive Plan Update for Augusta-Richmond County on Monday, March 5, 2018. The Planning and Development staff began an eight-month comprehensive planning process that will cover Richmond County, Hephzibah and Blythe. The current Comprehensive Plan was last updated in 2008 and focused on growth and land development through 2030. This 2035 Comprehensive Plan Update will set a vision and goals for growth and land development that will serve as a holistic blueprint to guide how and where growth will occur through 2035.

The plan will answer the following questions:

- 1. Where are we now?
- 2. What is the vision and goals for the future?
- 3. How do we achieve the vision and goals?

The Georgia Department of Community Affairs requires local governments to update their comprehensive plans every five years.
