
IN RE: GRAND JURY PRESENTMENT FOR THE NOVEMBER TERM 2019


RE: Grand Jury Presentment



A Sub-Committee was formed to inspect the Charles B. Webster Detention center. The applicable report is attached.


The Grand Jury respectfully submits this Presentment on the 14th day of January 2020 and requests that it is published.
