October 12, 2020	Advanced In Person (Early) Voting begins for the November General Election and Special Election. O.C.G.A. § 21-2-385

As soon as possible	Absentee ballots shall be mailed out as soon as possible prior to the General Election and Special Election Runoffs for Local and State Offices. **O.C.G.A. § 21-2-14. When the last day for the exercise of any privilege or discharge of any duty prescribed or required by this chapter shall fall on a Saturday, Sunday, or legal holiday, the next succeeding business day shall be the last day for the exercise of such privilege or the discharge of such duty.*
