# **HOPWA PROGRAM:**

- **ONLY FEDERAL PROGRAM DESIGNATED FOR PERSONS LIVING WITH HIV/AIDS**

- **PURPOSE:**

**IS TO ADDRESS THE SPECIFIC NEEDS OF LOW INCOME INDIVIDUALS AND THEIR FAMILIES LIVING WITH AIDS**

- **AUGUSTA, GA RECEIVED: \$ 1,055,049 IN FY2019**

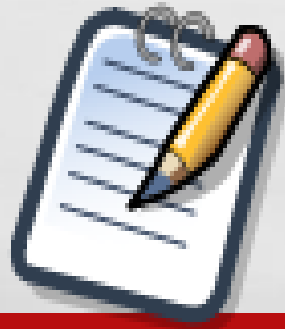


# REQUIREMENTS

- **MUST BE A 501C3 NONPROFIT**
- **MUST HAVE BEEN IN BUSINESS FOR AT LEAST TWO YEARS**
- **MUST HAVE A BUSINESS LICENSE**
- **SHOW PROOF OF WORKING WITH AIDS/HIV CLIENTS**
- **CASE MANAGEMENT EXPERIENCE**

# WHAT IS ELIGIBLE???

- **OPERATIONAL**
- **ADMINISTRATION**
- **CASE MANAGEMENT**
- **HOUSING INFORMATION**
- **TENANT BASED RENTAL ASSISTANCE**
- **SHORT TERM RENT MORTGAGE & UTILITIES**
- **HOUSING PLACEMENT**
- **SUPPORT SERVICES**



# ELIGIBILITY

- **ALL PARTICIPANT FILES MUST CONTAIN DOCUMENTATION THAT VERIFIES THE PARTICIPANTS' ELIGIBILITY TO RECEIVE HOPWA ASSISTANCE.**
- **ACCEPTABLE MEDICAL DOCUMENTATION OF HIV STATUS INCLUDE:**
  - **A STATEMENT OF HIV VERIFICATION SIGNED BY A PHYSICIAN, CERTIFIED HEALTH CARE WORKER, OR HIV TESTING SITE REPRESENTATIVE**
  - **SOCIAL SECURITY ADMINISTRATION RECORDS INDICATING THE NATURE OF A DISABILITY DETERMINATION**
  - **OTHER RELEVANT FEDERAL PROGRAM RECORDS VERIFYING HIV STATUS**
