Consent for Entry and Access to Property

In consideration of the benefits derived from participation in the Assisted Collection Services Program, I (we) agree to the following:

I (we) consent to employees and authorized representatives of Augusta, Georgia, including their authorized garbage collection haulers and contractors, entering and having continued access to my property for the following purposes:

1. Provide waste and recycling services;
2. Deliver, remove or repair containers used to provide waste and recycling services;
3. Coordinate, communicate, inform or enforce issues related to waste and recycling services; and;

I (we) ASSUME ALL OF THE RISKS OF PARTICIPATING IN THE ASSISTED COLLECTION SERVICES PROGRAM, including by way of example and not limitation, and any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them or because of their possible liability without fault.

I (we) understand, agree, and that acknowledge that Augusta, Georgia, its Mayor, its Commissioners and their directors, officers, employees, garbage haulers, contractors, representatives, and agents are NOT responsible for the errors, omissions, acts, or failure to act

to any party or entity as it relates to injury or property damage in regards to the collection of garbage, recyclable, or other materials collected in accordance with the Assisted Collection Services Program.

I (we) WAIVE, RELEASE, AND DISCHARGE from any and all liability, including, but not limited to liability arising from the negligence or fault of the entities or persons releases, for personal injury, property damage, property theft, or actions of any kind which may hereafter occur during participation in the Assisted Collection Services Program, THE FOLLOWING ENTITITES OR PERSONS: Augusta, Georgia, its Mayor, its Commissioners and their directors, officers, employees, garbage haulers, contractors, representatives, and agents.

I (we) agree to HOLD HARMLESS AND PROMISE NOT TO BRING LEGAL ACTION against the entities or persons mentioned in the previous paragraph from any and all liabilities or claims made as a result or participation in this Assisted Collection Services Program, whether caused by the negligence of the entities or persons mentioned in the previous paragraph or otherwise.

This Agreement shall remain in full force and effect until such time as the undersigned as described above has ceased to participate in the Environmental Services Department Assisted Collection Services Program or until written revocation of the Agreement is received by the Environmental Services Department of Augusta, Georgia.

This consent for entry and access, and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
